RINGKASAN

Berdasarkan data yang didapatkan dari buku register di Ruang IGD Jenderal Ahmad Yani Metro pada 2021 untuk kasus *Congestive Heart Failure* (CHF) sebanyak 167 dari 1.430 kasus penyakit dengan persentase 11,7%. Berdasarkan uraian diatas penulis merumuskan masalah “Bagaimana gambaran Asuhan Keperawatan Gawat Darurat dengan Gangguan Sirkulasi pada kasus *Congestive Heart Failure* (CHF) terhadap Tn. M di Ruang IGD RSUD Jenderal Ahmad Yani Metro?”

Tujuan penulisan laporan tugas akhir ini memberikan gambaran tentang asuhan keperawatan dengan gangguan sirkulasi pada kasus *Congestive Heart Failure* (CHF) secara komprehensif. Berdasarkan data pengkajian yang didapatkan pada kasus ini memunculkan beberapa diagnosa keperawatan, yang menurut teori tidak semua dapat ditegakkan karena disesuaikan dengan kondisi pasien. Rencana keperawatan dibuat sesuai teori berdasarkan SDKI, SLKI, dan SIKI 2018. Implementasi dilakukan sesuai rencana keperawatan dan evaluasi dilakukan berdasarkan hasil implementasi. Dari hasil pengkajian didapatkan diagnosa yaitu penurunan curah jantung, nyeri akut, dan intoleransi aktivitas. Adapun SLKI yaitu curah jantung, tingkat nyeri, toleransi aktivitas serta SIKI yaitu perawatan jantung, manajemen nyeri, dan manajemen energi. Setelah dilakukan tindakan keperawatan selama satu hari, evaluasi yang didapatkan semua masalah teratasi sebagian.

Simpulan dari laporan tugas akhir ini tidak semua proses keperawatan *Congestive Heart Failure* (CHF) sesuai dengan kondisi pasien pada kenyataannya. Saran hendaknya dapat menambah wawasan, pengetahuan, dan dapat meningkatkan mutu pelayanan tentang kasus *Congestive Heart Failure* (CHF)

ABSTRACT

Based on data obtained from the register book in the Emergency Room General Ahmad Yani Metro in 2021 for cases of Congestive Heart Failure (CHF) as many as 167 of 1,430 cases of disease with a proportion of 11.7%. Based on the description above, formulate the problem "What is the description of Emergency Nursing Care with Circulation Disorders in the case of Congestive Heart Failure (CHF) against Mr. M in the ER Room of General Ahmad Yani Metro Hospital?"

The purpose of writing this final report is to provide a comprehensive overview of nursing care for circulatory disorders in cases of Congestive Heart Failure (CHF). Based on the assessment data obtained in these cases, several nursing diagnoses emerged, which according to theory could not all be enforced because they were adapted to the patient's condition. Building Plan according to theory based on SDKI, SLKI, and SIKI 2018. Implementation is carried out according to plan and evaluation is carried out based on implementation results. From the results of the study, the diagnosis was obtained, namely decreased cardiac output, acute, and activity tolerance. The SLKI are cardiac output, pain level, activity tolerance and SIKI are cardiac care, pain management, and energy management. After taking action for one day, the evaluation found that all problems were partially resolved.

The conclusion from this final project report is that not all Congestive Heart Failure (CHF) nursing processes are in accordance with the actual conditions in reality. Suggestions should be able to add insight, knowledge, and can improve the quality of service regarding the case of Congestive Heart Failure (CHF)
