RINGKASAN

Prevalensi Diabetes Melitus di provinsi Lampung pada tahun 2018 berdasarkan diagnosis dokter pada penduduk semua umur yaitu 1,4% dari jumlah penduduk di Lampung. Pada tahun 2018 tercatat kasus penyakit diabetes melitus menduduki peringkat ke 4 dari 10 besar penyakit yang ada di Ruang Bedah RSUD Mayjend HM Ryacudu Kotabumi Lampung Utara.

Tujuan penulisan laporan tugas akhir ini memberikan gambaran Asuhan Keperawatan Pasien dengan Gangguan Aman Nyaman Pada Kasus Ulkus Diabetikum tentang pengkajian, diagnosa, rencana, implementasi dan evaluasi.

Diangnosa Keperawatan yang muncul adalah gangguan integritas kulit/jaringan, nyeri akut, ketidakstabilan kadar glukosa darah dan gangguan mobilitas fisik. Adapun SLKI yaitu integritas kulit dan jaringan, tingkat nyeri, kestabilan kadar glukosa darah, mobilitas fisik serta SIKI perawatan luka, manajemen nyeri, manajemen hiperglikemia, dukungan mobilisasi. Implementasi dilakukan sesuai dengan rencana keperawatan. Evaluasi yang didapatkan tidak semua masalah teratasi pada diagnosa gangguan integritas kult/jaringan dan nyeri akut masalah teratasi sebagian sedangkan diagnosa ketidakstabilan kadar glukosa darah dan gangguan mobilitas fisik masalah teratasi.

Simpulan dari laporan tugas akhir ini tidak semua teori proses keperawatan kasus ulkus diabetikum sesuai dengan kondisi klien. Saran hendaknya meningkatkan mutu pelayanan mengenai asuhan keperawatan. Dan memfasilitasi buku-buku edisi terbaru tentang ulkus diabetikum.

ABSTRACT

The prevalence of diabetes mellitus in Lampung province in 2018 based on diagnosis doctors in the population of all ages is 1,4 of the population in Lampung. In 2018 recorded cases of diabetes mellitus ranked 4th out of the 10 major diseases that exist in the Operating Room of the Mayjend General Hospital HM Ryacudu Kotabumi North Lampung.

The purpose of writing this final project report provides an overview of Nursing Care of Patients with Comfortable Disorders Comfortable in the Case of Diabetic Ulcer about the assessment, diagnosis, planning, implementation and evaluation.

Nursing diagnoses that arise are disorders of skin/tissue integrity, acute pain, instability of blood glucose levels and impaired physical mobility. The SLKI are skin and tissue integrity, pain level, stability of blood glucose levels, physical mobility and the SIKI wound care, pain management, management of hyperglycemia, mobilization support. Implementation is carried out in accordance with the nursing plan. The evaluation that was obtained was not all the problems were overcome in the diagnosis of the integrity of the skin/tissue integrity and acute pain the problem was partially resolved while the diagnosis of the impaired physical mobility problem was resolved.

The conclusion from this final project report is that not all theories of the nursing process of diabetic ulcer cases are in accordance with the client's condition. Suggestions should improve the quality of services regarding nursing care. And facilitate the latest edition of books about diabetic ulcers.
