**RINGKASAN**

Unit Kedaton adalah salah satu Unit Perkebunan yang terdapat di PT Perkebunan Nusantara VII. Lingkup usaha yang terdapat di Unit Kedaton berupa perkebunan karet dan Pabrik Pengolahan Ribbed Smoked Sheet (RSS) ISO SNI 9001: 2015. Unit Kedaton beroperasi pada tahun 1985 dengan kapasitas olah 10 Ton/ Karet Kering dan memiliki luas area kebun 5.126, 32 Ha dan luas area pabrik 5,09 Ha. Tujuan penelitian gntuk mengetahui gambaran penerapan kesehatan dan keselamatan kerja (K3) pada pekerja bagian produksi.

Penelitian ini bersifat deskriptif untuk mengetahui Gambaran penerapan kesehatan dan keselamatan kerja (K3) pada pekerja bagian produksi di PTPN VII Unit Kedaton Way Galih Tahun 2022.

Berdasarkan hasil penelitian yang didapat dari observasi ketersediaan, kondisi serta penggunaan APD sudah sesuai standar Permenaker NO.8 Th. 2010 tentang Alat Pelindung Diri. Selanjutnya ketersediaan rambu K3 sudah sesuai standar PP No. 50 Th 2012. Pengukuran pencahayaan dan temperatur sudah diatas NAB kecuali pencahayaan kantor teknik yang masih dibawah NAB yaitu 30 LUX. Perilaku karyawan juga menjadi penentu keselamatan kerja, dikarenakan pengalaman kerja, pemahaman K3 serta perilaku karyawan menentukan keamanan dan kenyamanan dalam pekerjaan.

**ABSTRACT**

Kedaton Unit is one of the Plantation Units found in PT Plantation Nusantara VII. The scope of business found in Kedaton Unit is rubber plantation and Ribbed Smoked Sheet Processing Plant (RSS) ISO SNI 9001: 2015. The Kedaton unit was in operation in 1985 with a sports capacity of 10 Ton/ Dry Rubber and has a garden area of 5,126, 32 Ha and a factory area of 5.09 Ha. The purpose of the study was to find out the picture of the application of occupational health and safety (K3) to production part workers

This study is descriptive to find out the Overview of the application of occupational health and safety (K3) to production part workers at PTPN VII Kedaton Way Galih Unit in 2022.

Based on the research results obtained from the availability observation, the conditions and use of AP conform to the standard of Candyaker No.8 Th. 2010 on Self-Protective Tools. Furthermore, the availability of K3 signs is in accordance with the PP No. standard. 50th of 2012. The measurement of lighting and temperature is above NAB except for the lighting of the engineering office that is still below NAB, which is 30 LUX. Employee behavior is also a determinant of job safety, due to work experience, understanding of K3 as well as employee behavior of menentack safety and convenience in the job.
